# The Rules of the Club

## 1. Club Name and Colours

- 1.1. The Club shall be named '*The Charlotteville Cycling Club*', hereinafter referred to as '*The Club*'.
- 1.2. Its headquarters shall be in Guildford, Surrey, at a location directed by the Committee.
- 1.3. The Club colours shall be Green, Red, White and Black provided that black is not the predominant colour.
- 1.4. The Committee shall review the design of the Club colours at least once every five years.

## 2. Aims & Objectives

- 2.1. The club shall exist to provide cycling and social activities for its members.

## 3. Constitution

- 3.1. The Club shall consist of a President, Vice Presidents, Honorary Life Members, First Claim members, Second Claim Members and Temporary Members.

## 4. Management of The Club

- 4.1. The Club shall be managed by a Committee composed of the President, Chair of the Committee, General Secretary, Treasurer, Welfare Officer, Racing Secretary, Communications Secretary, Social Secretary and three other members, all to be elected annually.
- 4.2. The Committee shall have the power to call Special General Meetings, to appoint Sub Committees, to suspend or expel a Member, subject to an appeal at a General Meeting, and to fill any vacancy on the Committee.
- 4.3. It shall exercise control over the expenditure of all monies and take such steps as may be necessary to maintain the activities and welfare of the Club.
- 4.4. Any Member of the Committee absent from three consecutive Meetings, without reasonable explanation accepted by a majority of the other Members, may be deemed to have resigned from the Committee.
- 4.5. Six Members shall form a quorum at Meetings of the Committee.

## 5. Membership

- 5.1. Membership of the club shall be open to anyone interested in the sport on application, regardless of sex, age, disability, ethnicity, nationality, sexual orientation, religion or other beliefs. However, limitation of membership according to available facilities is allowable on a non-discriminatory basis.
- 5.2. The club may have different classes of membership and subscription on a non-discriminatory and fair basis. The club will keep subscriptions at levels that will not pose a significant obstacle to people participating.
- 5.3. The club committee may refuse membership, or remove it, only for good cause such as conduct or character likely to bring the club or sport into disrepute. Appeal against refusal or removal may be made to the members.

## **6. Definitions of Membership**

### **6.1. President**

- 6.1.1. The President shall be elected or re-elected annually at the Annual General Meeting.
- 6.1.2. The President shall be a First Claim Member.

### **6.2. Vice Presidents**

- 6.2.1. Vice Presidents shall be elected for life or for as long as they remain a member of Charlottesville Cycling Club.

### **6.3. Honorary Life Members**

- 6.3.1. Nominations for new Honorary Life members shall be submitted to the General Secretary before October 31.
- 6.3.2. Honorary Life Membership may be conferred on First Claim members in the following way:
  - (i) Members of at least five years continuous membership, for outstanding services, by a majority vote at a General Meeting.
  - (ii) Rewarding those members who have greater than 40 years membership of the club. Such membership to be approved at a General Meeting.
- 6.3.3. Honorary Life Members shall have the same rights as a First Claim Member.

### **6.4. First Claim Members**

- 6.4.1. First claim Members shall not be First Claim Members of any other cycling club.
- 6.4.2. They shall pay appropriate subscriptions annually.

### **6.5. Second Claim Members**

- 6.5.1. Second Claim Members shall be Members who are First Claim Members of another cycling club.
- 6.5.2. They shall notify the Club Membership Secretary of the name of their First Claim Club.
- 6.5.3. They shall pay the appropriate Second Claim Members subscription.
- 6.5.4. They shall not be eligible to compete for any Club awards.

### **6.6. Temporary Members**

- 6.6.1. Temporary Membership shall confer only the right to ride in Private Time Trials in Club Events for a period of four consecutive weeks.
- 6.6.2. They shall not be Members of any other CTT affiliated Club
- 6.6.3. They shall pay the subscription for a Temporary Member and complete a Temporary Membership Form.
- 6.6.4. Temporary Membership may not be renewed.

## **7. Election of New Members**

- 7.1. Applicants for membership shall complete the membership application form either in printed form or via an approved online membership registration process.
- 7.2. The Membership Secretary shall ensure that the membership lists are up to date and that the Club Handbook is available on the club website and if requested by a member to send a printed copy to them
- 7.3. Applicants for membership shall only be permitted to ride in a Club event on two separate occasions prior to joining.

## **8. Members' Obligations**

- 8.1. Members, or their substitutes, shall assist at least once each year with the marshalling, organising or otherwise helping with the running of at least one of the Club's events.
- 8.2. Members shall adhere to the club's Code of Conduct, as published by the Committee and amended from time to time.
- 8.3. Upon joining, Members shall provide details of an emergency contact to the Membership Secretary and notify the Club of any changes to those details as required.
- 8.4. Each Member shall satisfy themselves that they hold adequate insurance cover for all cycling related activities that they undertake, and acknowledge that the Club offers no protections or indemnities to Members.
- 8.5. For all club organised events, with the exception of coached sessions arranged by the Youth section of the club (the "Rascals"):
  - 8.5.1. members, or prospective members, under the age of 16 must be accompanied by a parent or guardian; and
  - 8.5.2. members, or prospective members, aged 16 or 17 must provide written parental consent in advance, unless accompanied by a parent or guardian..

## **9. Resignations**

- 9.1. Members wishing to resign shall notify their intention to the General Secretary in writing.
- 9.2. Members wishing to become First Claim members of another club, shall notify their intention to the General Secretary.
  - 9.2.1. If such members wish to remain in the Club as Second Claim Members, they shall notify the General Secretary of their intention, giving the name of the club that they will be joining as a First Claim Member.
- 9.3. Any member whose subscription is unpaid on 1st March of any year is deemed to have resigned, except in exceptional circumstances at the discretion of the Committee.

## **10. The Club Year**

- 10.1. The Club Year shall start on 1st November and end on 31st October.

## **11. Subscriptions**

- 11.1. Subscriptions shall be paid upon election, and shall be due for renewal on January 1st each year except when rule 11.1.2 applies.
  - 11.1.1. Payment shall be made to the Membership Secretary or directly to the Charlotteville Cycling Club via any approved payment method (cheques shall be made payable to the Charlotteville Cycling Club).
  - 11.1.2. Any member elected after 31st August in any year is deemed to be a member for the remainder of the calendar year of election and the whole of the following calendar year.
  - 11.1.3. Upon payment the register of members shall be updated by the Membership Secretary
- 11.2. Annual subscriptions and Temporary Membership subscriptions shall be as prescribed from time to time at a General Meeting of the Club.
- 11.3. Subscriptions paid by Temporary Members shall be deducted from their first annual subscription if they become First Claim Members of the Club before their Temporary Membership expires.
  - 11.3.1. Such Members shall be required to complete a Membership Application. (See Rule 7.1).
- 11.4. No members shall be eligible to race if their current subscriptions are unpaid.

- 11.5. The cost of affiliation to British Cycling, which shall be optional, shall be additional to the Club subscription.
- 11.6. Membership of the Club and payment of subscriptions shall not confer any rights, indemnities or insurance upon an individual, save where members are acting in an official capacity; members should satisfy themselves that they have sufficient insurance cover for all cycling activities in which they participate.

## **12. The Club Accounts**

- 12.1. A current Bank Account shall be maintained in the name of the Club, with the Chair of the Committee, the General Secretary and the Treasurer as Trustees.
- 12.2. Withdrawals from the Account must be made by cheques/electronic payments approved by two of these Officers and no payment shall be made until approval has been given by the Committee.

## **13. General Meetings**

- 13.1. The Annual General Meeting shall be held during December,
  - 13.1.1. to receive the Annual Report and Balance Sheet for the year ending October 31 preceding,
  - 13.1.2. to elect a President, Vice Presidents, Officers, Delegates and Committee Members for the current year,
  - 13.1.3. to consider resolutions on the Agenda,
  - 13.1.4. to transact General Business.
- 13.2. At least eight weeks notice of the date of the Annual General Meeting shall be given to every member.
- 13.3. Items for inclusion on the Agenda must be sent to the General Secretary to reach him/her no later than October 31.
- 13.4. Copies of the agenda shall be made available to all Members at least two weeks before the date of the Meeting.
- 13.5. A Special General Meeting may be called at any time by a resolution of the Committee, or, by a requisition supported by at least 10 Members and sent to the General Secretary.
- 13.6. At least seven days notice must be given to all Members of any Special General Meeting.
- 13.7. The business at a Special General Meeting shall be confined to the matters appearing on the Agenda.
- 13.8. Any resolution concerning the alteration of Club Rules must appear on the Agenda.
- 13.9. Any addition, amendment or deletion to a Club Rule shall clearly show the wording of the existing Rule, and exact changes being proposed.
- 13.10. No Rule shall be added, amended or deleted unless the resolution is supported by at least two thirds of the votes cast.
- 13.11. The Quorum at a General Meeting shall be 20.
- 13.12. Only First Claim Members may vote at General Meetings.
- 13.13. First claim members who are unable to attend the Annual General Meeting shall be allowed to cast their votes in advance. They must notify the General Secretary of their nominated votes in writing at least two days prior to the meeting.

## **14. Club Trophies & Property**

- 14.1. Responsibility for the care and safe custody of the Club Trophies and Property shall rest with the holder or persons to whom it is entrusted.

- 14.1.1. Any damage or loss to any Trophies or Club Property must be reported to the General Secretary immediately that it is noticed.
- 14.1.2. The Club shall arrange for repairs to Trophies and Property as necessary; responsibility for payment of such repairs shall be decided by the Committee.
- 14.2. The Committee shall however, insure such Trophies and Property as it thinks fit.
- 14.3. All Club Trophies shall be perpetual Trophies, and may not be won outright, unless special arrangements have been made with the donor, and accepted by the Members of the Club at a General Meeting.
- 14.4. Club Trophies shall be returned at the Annual General Meeting or as directed by the Committee.
- 14.5. Holders of Club Property must return it as directed, within seven days, when called upon to do so by the Committee, or Members of the Club at a General Meeting.
- 14.6. The Club shall have an annual Inventory of all Club Property, which shall indicate where such property is held.
  - 14.6.1. All holders of Club trophies and Property are responsible for informing the Recorder of Club Property of any items that they have in their possession.

## **15. Property & Funds**

- 15.1. The property and funds of the club cannot be used for the direct or indirect private benefit of members other than as reasonably allowed by the Rules.
- 15.2. The club may provide sporting and related social facilities, sporting equipment, coaching, courses, insurance cover, medical treatment, event expenses, post event refreshments and other ordinary benefits of an amateur sports club.
- 15.3. The club may also in connection with the sports purposes of the club:
  - (i) Sell and supply food, drink and related sports clothing and equipment
  - (ii) Employ members (though not for riding) and remunerate them for providing goods and services, on fair terms set by the committee without the person concerned being present
  - (iii) Pay for reasonable hospitality for visiting teams and guests
  - (iv) Indemnify the committee and members acting properly in the course of the running of the club against any liability incurred in the proper running of the club (but only to the extent of its assets)

## **16. Club Records**

- 16.1. Club Records shall be recognised at the distances and times set out in the lists of Standard Times, Place-to-Place, Straight Out, and Track Records
- 16.2. New Records must be better than the existing Record, or equal or better than a Class A Standard Time or the lowest Standard for Place-to-Place Records.
- 16.3. Records may be established in any recognised event, provided that the rider or riders are paid up First Claim Members of the Club.
- 16.4. Special Club Certificates shall be presented for every ride passed by the Committee as the best on record.
- 16.5. Claims must be made in writing to the General Secretary.

## **17. Club Championships**

- 17.1. Special Championship Plaques shall be awarded each year to First Claim Members, in the following categories:  
*NOTE: All category definitions are to be in accordance with those laid down by the relevant governing bodies.*

- 17.2. The **Club Time Trial Champion** who shall be the Member (Male or Female, of any age) with the highest average speed on a single bicycle and/or tricycle in recognised events at 25, 50, 100 miles and 12 hours.
- 17.3. The **Short Distance Time Trial Champion** who shall be the Member (Male or Female, of any age) with the highest average speed on a single bicycle and/or tricycle in recognised events: 2 of 10 miles, 2 of 25 miles and 1 of 50 miles.
- 17.4. The **Club Junior Time Trial Champion** who shall be the Junior or Juvenile Member (male or female) who has the highest average speed for three rides at 10 miles and two rides at 25 miles.
- 17.5. The **Club Juvenile Time Trial Champion** who shall be the Juvenile Member (male or female) who has the highest average speed for three rides at 10 miles.
- 17.6. The **Club Lady Time Trial Champion** who shall be the female Member (of any age) who has the highest average speed for three rides at 10 miles and two rides at 25 miles.
- 17.7. The **Club Veteran Time Trial Champion** who shall be the Veteran Member (male or female) with the best aggregate plus on standard over 2 events of 10 miles, 2 events of 25 miles and 1 event of 50 miles based on current VTTA standards.
- 17.8. The **Club Track Champion** who shall be the Member (male or female, of any age) who is the winner of an omnium of three events, such events to be determined by the committee, together with their venues, on an annual basis after consultation with the Track Secretary. Failing this, the Member deemed by the Committee to have done the most meritorious ride or rides in Track competition.
- 17.9. The **Club Senior Road Race Champion** who shall be the Senior Member (male or female) who has gained in Scratch Road or Circuit races the highest number of points in accordance with those awarded under the B.C. Rules of Racing for upgrading of category.
- 17.10. The **Club Junior Road Race Champion** who shall be the Junior or Juvenile Member (Male or Female) who has gained in Scratch Road or Circuit Races the highest number of points in accordance with those awarded under the B.C. Rules of Racing for upgrading of category.
- 17.11. The **Club Cyclo-Cross Champion** who shall be the Member (male or female, of any age) deemed by the Committee to have done the most meritorious ride in an event promoted under the rules of British Cycling.
- 17.12. All qualifying rides must be done by paid up First Claim Members.
- 17.13. Members shall submit their results to the Honorary Recorder by November 30.
- 17.14. All counting events, except Cyclo-Cross, must take place between January 1 and October 31, both dates inclusive.
- 17.15. Where no claim has been received for a particular Championship, the Committee is empowered to award a trophy on merit, as it sees fit.

## **18. Affiliation to Organisations**

- 18.1. Proposals for additions or deletions of affiliated membership of other organisations shall be submitted to the General Secretary by October 31 for consideration at the Annual General Meeting.

## **19. Welfare, Safeguarding & Code of Conduct**

- 19.1. The club shall adopt and adhere to all relevant policies and procedures for the welfare and safeguarding of children and vulnerable adults as set out by British Cycling, including the British Cycling Safeguarding Children and Young People Policy.
- 19.2. The club will set out its expectations of member behaviour in a Code of Conduct, such document to be used as the basis for any disciplinary hearing (see Section 5).

19.3. The club shall ensure suitably qualified person or persons are appointed as Welfare Officer(s) with specific responsibility for the safeguarding of children and vulnerable adults

## **20. Winding up The Club**

20.1. The members may vote to wind up the club if not less than three quarters of those present and voting support that proposal at a properly convened general meeting. The committee will then be responsible for the orderly winding up of the club's affairs. After settling all liabilities of the club, the committee shall dispose of the net assets remaining to one or more of the following:

- (i) To another club with similar sports purposes which is a charity
- (ii) To another club with similar sports purposes which is a registered CASC
- (iii) To the club's national governing body for use by them for related community sports

## **21. Priority**

21.1. Where there is a conflict between any of the above Rules ("Key Rules") and any other rule or rules, the Key Rule(s) will take priority.

## **22. Matters not covered by Rule**

22.1. The Committee shall have the power to decide upon all matters not covered by these Rules.



# Annex A

## Regulations for Club Time Trials & Place-to-Place Records

### 1. Time Trials

- 1.1. The Club Time Trials will be conducted in conformity with the current Cycling Time Trials (“CTT”) Regulations.
- 1.2. For Handicap events, Novices events and events of 25 miles and over, a completed entry form and fee must reach the Event Secretary at least 12 days prior to the date of the event. Entries received after this time may only be accepted as ‘Private Trials’.
- 1.3. For events not covered by Rule 1.2 entries are ‘on the line’ provided that the rider has registered and paid the appropriate fee before starting the event.
- 1.4. For riders under the age of 18, a parental consent form must be completed to conform to CTT Regulations.
- 1.5. In all events, except scratch events, medals will be awarded on the following scale:

Number of Entries	Fastest Time or Greatest Distance	Handicap
1 - 6	1st	1st
7 - 12	1st	1st & 2nd
13 +	1st & 2nd	1st, 2nd & 3rd

- 1.6. In Scratch events, medals will be awarded on the following scale:

Number of Entries	Fastest Time or Greatest Distance
1 - 6	1st & 2nd
7 +	1st, 2nd & 3rd

- 1.7. Junior events shall be confined to Junior and Juvenile Members (male or female).
- 1.8. Awards will be made to Senior, Junior and Juvenile Members (male or female) with the highest average speed on aggregate for three rides in Club Event 10's.

### 2. Private Trials

- 2.1. Private trials may be allowed in conjunction with Club Events at the discretion of the Event Secretary, and entries may be accepted up to the time of the event, except in the case of rides for a Standard Award.
- 2.2. A fee similar to that for the event must be paid.
- 2.3. For private trials not held in conjunction with Club Events, entries must reach the Club Events Secretary at least three days before the Trial. Riders must arrange for ‘checkers’ at all necessary points, and for Club Timekeepers to officiate.
- 2.4. A fee of £1.00 will be payable, which shall cover the Standard Medal charges where applicable.
- 2.5. Only R.T.T.C. approved courses may be used.
- 2.6. Private trials shall not be eligible to count towards Club Championships.

### 3. Standard Medals

- 3.1. Three classes of Standard Medals- A, B, and C- will be awarded for rides which are equal to or faster than those set out in the list of Standard Medal Times.
- 3.2. Standard Medal rides may be performed in any CTT recognised Open, Association or Charlotteville Club Events, or in Private trials in accordance with Club Regulations.
- 3.3. Entries made in writing and accompanied by a fee of £1.00 must reach the Club Events secretary at least two clear days before the date of the event.
- 3.4. Riders must be under the Club's name (both riders in the case of Tandem Rides) and must beat their previous best at the distance entered for.

#### **4. Place-to-Place Records**

- 4.1. Place-to-Place Records will be recognised between the places listed in the current Club Handbook.
- 4.2. The rides in all cases are 'out and home', finishing at the starting point.
- 4.3. Current Road Records Association Regulations regarding unpaced riding, following riders and handing up of refreshments will be strictly enforced.
- 4.4. Notices of Record Attempts must reach the Club Event Secretary at least seven days before the date of the proposed ride. A schedule of the route and times must be forwarded at the same time.
- 4.5. No fees will be charged.
- 4.6. Riders must arrange for Checkers, at the precise turning points listed in the Club Handbook, for Observers and Checkers as stipulated by the Club Events Secretary and for a Timekeeper (who ipso facto is an Observer) to officiate.
- 4.7. Any following vehicle shall carry at least one Observer officially appointed by the Club Committee.
- 4.8. All Members of the Club Committee shall be empowered to act as Observers.
- 4.9. To qualify for a Record, the ride must be faster than the existing Record or Standard Time for the journey.
- 4.10. Where two or more Records are attempted in one day, over the same route, riders must be dispatched so there is at least one hour's riding time between them at the start.

#### **5. Track Records**

- 5.1. Track Records shall be Unpaced, Standing Start and Flying Start, and shall be conducted under the applicable current British Cycling Rules, except that:-
- 5.2. any 'flat' on the track need not be rendered unrideable and
- 5.3. riders must arrange for an official Club Observer and a Club or B.C. Timekeeper to officiate.

#### **6. General Rules for Claiming Records**

- 6.1. Claims for Records must be made within one month of the date of the performance upon a form, which may be obtained from the General Secretary.
- 6.2. A copy of the result sheet appertaining to the Claim must be submitted, once available, to confirm the ride undertaken for the Claim.
- 6.3. Entries for Time Trials, Private Trials, Standard medal Rides, Place-to-Place and Track Records will not be accepted unless the current Club subscription, and entry fees have been paid.

## The Guildford Cup

Hallmarked 1904 and believed originally to have been a trophy of the former Guildford Cycling (& [in 1904] Motoring) Club (1877-1914), it was presented to Charlotteville by John Foster in c1920 and initially awarded to the winner of the 2 Miles Scratch Race.

From 1929 to 1999 it was awarded to the winning team in an Inter-Club 50 contested by members of the Charlotteville CC, the Century RC and the Wessex RC, where the winning Club was that with the lowest aggregate time of its four fastest riders. In 2000 it was awarded to the winning team in an Inter-Club 30 held on the same basis, but was -not awarded- in 2001 or 2002.

From 2003 the trophy has been awarded to the winner of the main race at the Guildford Town Centre Races.

## Vic Jenner Memorial Trophy (Open 50 Mile Time Trial)

To commemorate Vic Jenner who was responsible more than anyone for raising the Charlotteville CC from being an obscure country club into an internationally known one. From the late 1920s until his death in 1964 Vic was deeply involved as rider and administrator in all aspects of the sport nationally and locally.
